This is in reference to and in furtherance of our earlier Intimation dated 09th October, 2025, pursuant to Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations 2015 conveying the approval of the Resolution Plan submitted by JTL Limited ("Resolution Applicant"), by the Hon'ble National Company Law Tribunal, Delhi Bench-III ("NCLT") vide its order pronounced on 9th October, 2025.

Pursuant to Regulation 38(4) of IBBI (Insolvency Bankruptcy Board of India) (Insolvency of Corporate Persons Regulations), 2016 read with the resolution plan submitted by the Resolution Applicant. After the approval of the Resolution Plan by the Hon'ble Adjudicating Authority, the Resolution Professional is required to constitute a Monitoring Committee to oversee and ensure the effective implementation of the approved Resolution Plan

Further in pursuance to the oral pronouncement of order by Hon'ble NCLT on 09th October 2025, the Resolution Plan stand approved. Accordingly, the Monitoring Committee is constituted in terms of the clause resolution plan with the following 3 (Three) members to oversee the effective implementation of the Resolution Plan:

- 1. Mr. Brijesh Singh Bhadauriya (the erstwhile Resolution Professional)
- 2. Mr. Amrender Kumar Yadav (Representative of the Successful Resolution Applicant)
- 3. Mr. Sachin Dev, the Deputy General Manager (Union Bank of India) (Representative of the Committee of Creditors)

*(Kindly note that the Lead Bank – Union Bank of India shall act as the nominee of the Committee of Creditors (CoC), to be represented by any of its authorised officers from time to time. Presently, Mr. Sachin Dev, Deputy General Manager.)

In view of the above, the undersigned has demitted the office of the Resolution Professional of RCI Industries & Technologies Limited, Corporate Debtor and assumed the office of Chairman of the Monitoring Committee constituted to oversee the implementation of the Resolution Plan of the RCI Industries & Technologies Limited as approved by the Hon'ble NCLT on 09th October 2025.
